Good liaison with Cathy Berkeley who also sends through complaints. Mended gates and stiles. Hereford Council give furniture (stiles, etc) and landowners do the work.

Cllr Steeds reported that the stile which has long been in need of repair has now been fixed, but the cross bar is too high - a kissing gate would be better.

- 15/21 **Public Participation** members of the public are allowed 10 minutes to address the Council John Sallis from Linton Industrial Estate Unit 15 was invited to speak. Mr Sallis reported that many items were being stolen from the Industrial Estate and the police did not appear to be assisting in any way. Although the perpetrators have been caught on CCTV and finger prints found there have been no convictions and crimes were now not being reported. It was believed that residents from the travellers' site were causing this problem and Mr Sallis asked that BGPC and HC try to put a stop to this. Cllr Fellows and Cllr Williams reiterated the message from PC Meek that all acts of crime must be reported and a crime number obtained.

Cllr Swinford to talk to police and Hereford Council at a senior level as damage had been done to the travellers' site since it has been refurbished.

Cllr Fellows suggested Mr Sallis attend the next meeting.

Councillors asked about the dumping on the rail track as this was felt to be a health and safety issue and a danger to Environmental health. The Clerk was to report this issue again.
