MINUTES of the meeting of Brockhampton Group Parish Council held on Thursday 16th January 2014 at 7.30pm at Brockhampton Primary School

PCSO Steph Annette was available at the start of the meeting to answer questions about the parishes and give a short report of policing in the area.

14/04 Clerk's Report:

Update on the discussions from the November meeting and points of information:

- CiLCA
- Grit bins Cllr Swinford to research the price for buying and the Clerk to establish who would fill these up with salt.
- Dog waste bins Cllr Rock had been in conversation with Balfour Beatty about these. Balfour Beatty would subsidise spades or golf stick, but not empty bins. It was suggested that there needed to be liaison with BDCA as if waste was flicked into bracken the contamination would still occur. Can bins can be relocated.
- Road problems 6 drains still blocked rubbish really bad too by Saltmarsh castles culverts above drive to Upper Norton Farm the Clerk to report to Balfour Beatty.
- SLCC Regional Conference
- Houses of Parliament
- Website update
- The flowerbeds outside the Halo building in Bromyard had been given over to the Royal British Legion to use as a commemorative garden and a place for services as an alternative to the sheep. Councillors asked if they might be informed of the official opening.
- 14/05 **Public Participation** members of the public are allowed 10 minutes to address the Council Mr Watkins Cllr Swinford had a meeting with water expert 3 years ago and nothing has yet been done. Problem with Mr Moore the issues do not seem to have been resolved. What is the time limit on the condition for this planning? Cllr Swinford to check time limit. HC planners to write a letter to Mr Moore this is now three years. Councillors felt it was important to show we were still interested, and the Clerk was asked to write to Herefordshire Council.

14/06 Report from the Ward Councillor - Cllr Gary Swinford

- Herefordshire Council Budget meeting
- Council tax up 1.9%
- School transport Overview and Scrutiny Committee call in. Recommendation: Nearest school within the county and not cut those with SEN this has now gone back to cabinet.
- Bromyard Library safe for next financial year, but then what?
- Linton Industrial Estate how can this be developed need more employment land talking to three owners, plus Herefordshire Council this may take time to come to fruition.
- Balfour Beatty Burley Lane bottom keeps flooding. Ditch from Burley Lane up to Wash Croft farm. Plus David Hancock's water/ditch problem.
- Layby get collective view of PC do we want layby closed?
- Traveller's Camp delayed because of bats, then a problem with the contractors, this has now had a knock-on effect the local schools as they have missed out on the funding from pupils. Cllr Fellows asked Cllr Swinford to keep the Parish Council updated.
- Tesco resubmitted application and Porthouse is going to be part housing and part industrial.

14/07 To receive reports from:

BDCA and **Bringsty Common** – Cllr Friend

BDCA - Evan Bowen Jones has resigned as Chair as he is going to work for Herefordshire Nature Trust and so there is a conflict of interest. Short listing for warden - 12 applicants. Swing bars/disabled access (easy access) - Tom Fisher given a glowing report. Access across muddy ditch, hotly debated and this has now been agreed. British Standards for wheelchair access - waiting for better weather.

Bringsty - applying for heritage lottery fund to restore old drover's pond. Cllr Friend asked for a letter of support from the Parish Council.

Police Liaison Group – covered by the visit from PSCO Steph Annette.

Bromyard Relief in Need – Cllr Brazier

The Charity had produced 34 hampers over the Christmas period – one had been declined. A new Clerk was starting soon.

The possibility of a Parish Council donation was discussed, although Cllr Brazier felt it may be more appropriate to steer these funds to Helping Hands.

- 14/11 To discuss the subsidy in replacement of the Joint Burial policy.

The Clerk had been asked to look the lawfulness of the provision made by Brockhampton Group Parish Council for those being buried in the Bromyard and Winslow Town Council Cemetery. She had taken legal advice from the SLCC:

'There is a specific power (in section 214(6) LGA 1972 for a parish council to contribute to the expenses of another burial authority where residents of your area are buried in that authority's cemetery but there is no specific power to make a contribution towards residents' burial fees. If you do not have the general power of competence you can use section 137 subject to the normal conditions (council must be satisfied that expenditure is for the benefit of the area or its inhabitants, benefit must be commensurate with the expenditure and total section 137 expenditure must not exceed the annual limit)'. It was AGREED that councillors were happy with this response.

The Clerk was asked to circulate a draft policy for approval at the next meeting.

14/12 Planning: To consider the application: P133430/F Brockhampton Academy, WR6 5TD – Erection of storage shed to rear of main building Cllr Land gave an account of the works planned before leaving the room. APPROVED
