14/80 Report from the Ward Councillor - Cllr Gary Swinford

- By-elections both won by non-Conservatives. Conservatives are now in the minority. If all the others could work together they could form an alternative administration.
- Concerned about planning economic development suffering and enforcement is difficult to achieve.
- Employment land Core Strategy calling for 500 houses in Bromyard by 2031, and this calls for more employment land. Therefore 5 hectares of employment land had to be found. As Hereford Council failed to find that employment land, especially as they gave some away in the past, Bromyard and Winslow Town Council were charged with finding this. Parish Council can make representations when the Core Strategy is being inspected.
- Access Road into trading estate seem to be making progress hopefully this financial year.
- Lay-by blockage now in place
- New BT cabinet opposite Linton Court this is obstructing the view of some residents
- Exit from Down's Car Park visibility poor
- Ditching both sides of Downs Road this would be a good job for a new Lengthsman.

There was a great deal of discussion regarding the Linton Industrial Estate. Summarised below:

- Questions: Porthouse industrial or light industry?
- Linton: Due to lie of land there is not five hectares that are useable. It will also be an eyesore and totally inappropriate in the landscape. Topography is wrong.
- Land beyond Hardwick behind St Peter's School allocated for housing
- Concern about the fact that there was a public meeting in a neighbouring ward about land in our parish.
- Page Swinford Partnership not the consultation firm for this.
- Can we put in an objection to this and say we're totally opposed.
- Process wrong B&WTC not BGPC lack of consultation
- Letter to Core Strategy people circulate draft with Minutes
- Agenda next time
- Obtain Minutes from the B&WTC Planning Minutes and any other documents
